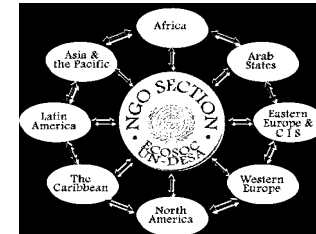

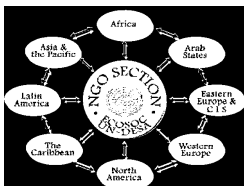

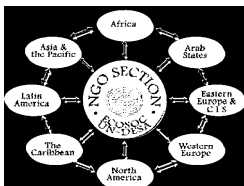
# About FORMIT

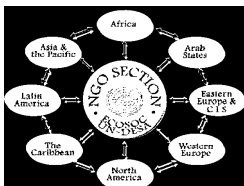
## About FORMIT (2)

## About FORMIT (3)

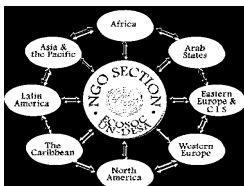

- **Formit Servizi** is officially registered with CNIPA (National Centre for IT in Public Administrations) for the monitoring of major contracts in the Public Sector and it is ranked as first for the number of large scale contracts being monitored up to present.



# About FORMIT (4)

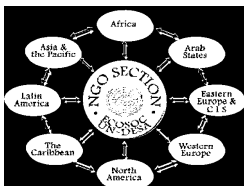
**FORMIT** activities are developed in partnership with different Bodies, both at national and international level, such as:

- The **State Administrations** interested in high technology initiatives as well as evaluating scientific and technological development scenarios and interested in identifying the relevant resulting specific training needs;
- **Academias**, in their role of key actors in scientific and technological research, coupled with advanced training;
- The major **National and International Institutes of Scientific Research** involved in areas of innovation, monitoring, documentation and technology transfer;
- **Enterprises**, in areas of exploitation, innovation and implementation of technological processes;
- The **Supranational Bodies**, such as the **European Commission**, for identifying scenarios related to development of technologies and their exploitation.



# FORM IT Achievements

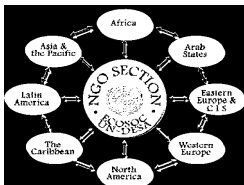
- Successfully performed almost 100 large scale projects related to deployment of ICT initiatives in the Public Sector;
- Supported Public Administrations to manage ICT projects the overall value of which is in excess of 1,000 million Euro;
- Carried out training activities for more than 1,000 Researchers from technical industry and about 8,000 Officials from Public Order and Security Bodies;
- At present: approximately 30 ongoing projects.
